Administration Report:

A. Dallas Bell – Success Cyber Schools – Dallas Bell presented on Success Virtual + Learning Centers. Success is a non-traditional education program partnering with public school systems to better serve students. The Learning Centers focus on students who have dropped out or are at-risk for not completing high school. Success combines virtual, online courses with the optional support of physical brick and mortar tutoring centers. Their facilities and technology equip students with all of the tools they will need to succeed. The staff members at Success are selected carefully, ensuring all Relationship Managers/Teachers have the mindset of a counselor and a heart for helping youth. The Learning Centers provide an environment in which building relationships and providing support is just as important as learning. Success strives to invest in the lives of kids who do not have opportunities, and give them hope. The proposal is that Benzie Central become a charter authorizer for facilities in Southeast MI that will follow a similar model to Success VLC sites, but through a "cyber school" authorization structure from the state of Michigan. As the Charter authorizer, we would have oversight over the school and be able to collect a 3% administrative fee which would be utilized for the benefit of Benzie Central students. The board is encouraged to read up on materials regarding the proposal and take action at a later meeting.

B. Budget Hearing –Director of Finance, Michele Murray, presented the board with the recommended 2018-19 Final Budget Amendment. Amendment was reviewed with revenue recommended to increase from \$15,011,587 to \$15,169,488 and expenditures recommended to decrease from \$14,640,030 to \$14,283,138. The fund balance is now expected to end at \$2,399,181. The initial 2019-20 Budget held end of year revenue at \$14,417,955 and end of year expenditures at \$14,807,219, which would set the end of year fund balance at \$2,009,917. Mr. Olson and Mrs. Murray emphasized that the budget amendment was impacted by a number of factors and delineated what a number of those were, including invoices that were unable to be processed during this fiscal year as well as a number of revenues that were different than expected or unexpected. It was also clarified that our 2019-20 proposed budget is based on anticipated state action, but that this was truly a guess as the state's budget is far from determined at this point. Board members should anticipate further discussion and a substantive budget amendment in the fall. Overall, the budget was a very positive one, with the district continuing to be in good financial standing despite many outside challenges and pressures.
