Administration Report:

A. Budget Hearing – Director of Finance, Michele Murray - Director of Finance, Michele Murray, presented the board with the recommended 2019-20 Final Budget Amendment. Amendment was reviewed with revenue recommended to increase from \$14,682,823 to \$14,747,785 and expenditures recommended to decrease from \$14,458,736 to \$14,071,911. The fund balance is now expected to end at \$2,633,404. Mrs. Murray explained the decrease in expenditures was impacted primarily by the school closure due to COVID-19 and the reclassification of general fund expenditures to the food service fund for the delivery of school meals. The initial 2020-21 Budget predicted the end of year revenue at \$13,240,552 and end of year expenditures at \$14,120,145, which would set the end of year fund balance at \$2,205,599. This was based on a student drop of fifty. Mr. Olson emphasized that both the FY20 and FY21 proposed budgets are truly a guess as the state's budget is far from determined at this point. Board members should anticipate further discussion in August and a substantive budget

amendment in the fall. Overall, the budget was a very positive one, with the district continuing to be in good financial standing despite many outside challenges and pressures. However, there still stands a possibility of a 2019-20 proration and potentially more than a \$700 decrease in foundation allowance for the 2020-21 school year.
