Revisions from CD Owner "Page Turn"

Transportation Building (these changes will have to be in Addendum No. 1)

Sheet C3.1:

- Reroute sanitary north then east (to the septic field) so the smallest length of piping is installed under the asphalt paving
- Eliminate (6) bus parking spaces (Owner only needs 24 spaces); shorten the asphalt paving (at the east) by the width of the three bus parking spaces
- Reduce width of the concrete paving at the bus parking spaces by half (Owner only wants the front bus wheels on concrete; rear wheels will be on asphalt)
- At the west wall of the Transportation Building, Owner wants a 5' wide concrete sidewalk (adjacent to the asphalt) and a 5' wide strip of river rock (adjacent to the building; snow from the roof will fall and pile up on the river rock). Adjust the parking spaces and aisles west of the building to "find" the additional 5' of space.
- AARON: please provide Amiee with an aerial image with the Transportation Building site plan line work overlaid. She wants to share the image with the forester who will be cutting down all the trees.

Sheet A3.2:

 Change the roof on the service bay building to a single slope roof with the "high" side located at the overhead service doors. Owner wants to eliminate "snow fall" at the overhead service doors.

Sheet A8.1:

• Owner would like FRP panel installed on the walls in the two toilet rooms instead of just high performance paint

Electrical Site Plan:

- Adjust (or eliminate?) light poles for revisions to the overall length of the bus parking lot.
- Adjust power for bus engine block heaters as well

Lake Ann CR Addition (these changes will be issued with 10/28 CD's)

Sheet A1.3:

• Enlarged toilet room plan: move TA-5 and TA-8 to the outside face of the wall they are currently indicated on.

Sheet A1.13:

- Interior Elevations for Student Cubbies: revise so the bottom of the cubbies are 6" above finish floor elevation. Owner wants 6" of space (below the cubbies) for student boots / shoes.
- Change the tackboards above the sinks to mirrors

Sheet A6.1:

• Change all exterior doors (like Door #300A) to "NL". Owner does not want a lot of glass in these doors.

• Door #300A: Owner wants a card reader at this door.

Mechanical:

• Owner wants ionization devices in all new mechanical HVAC units

Electrical:

- Door #300A: Owner wants a card reader at this door.
- PreK Room #200: power for ceiling speakers (see tech item below).

Sheet E0.1:

• Composite Electrical Floor Plan appears to have an old background. Update.

Technology:
