2. Marzano Training – Rick Vandermolen –

Boards are required to have training in how to evaluate the superintendent. There are 6 domains or areas of school level leadership that are used to set up the Marzano evaluation. This is the same type of evaluation that is used for the teachers which helps to keep continuity within the district. Marzano uses a scale of 1 to 4 to rate with 1 being not using and 4 being innovating. We touch base every 3 months to update on the goals of the superintendent and to review data regarding those goals. We discuss the areas of main focus and priority from the board's perspective.

3. Strategic Plan -

Brian and Lori Pearson with Alpine Educational are presenting the Strategic Planning Process. The focus is thinking ahead and looking upstream to help shape a plan for a successful outcome for students. The timeline would start soon and have a final report presentation in December with the Superintendent. Then this report would be presented to the BOE at the January 2026 board meeting. Estimated cost \$7,000.00

4. Sinking Fund -

Need to discuss getting a sinking fund back on the ballot. It is needed to keep our district operational considering our high transportation costs. During the bond projects we used a lot of sinking fund dollars to complete the projects. This is mainly because the estimated cost of the bond project ended up costing 30 to 40% more than the original estimate due to the length of time that the project took and COVID inflation. We still have more windows to replace. There will be 2 election opportunities in 2026 to have the sinking fund added without cost to those ballots.
